

The purpose of this modification is as follows:

To obligate funds in the amount of \$80,000.

Accordingly, the following section of the contract is hereby modified:

1. Under Paragraph 4 - CONSIDERATION AND OBLIGATION CLAUSE, paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated with respect to this task order is **\$295,100**. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations under this task order, from date of award through this modification, is given below:
