The Ohio Department of Health has finalized the amendments to rules in Ohio Administrative Code Chapter 3701:1-58 "Medical Use of Radioactive Materials" and Ohio Administrative Code rules 3701:1-46-43 and 3701:1-46-44. The effective date of the rules was December 22, 2008. The rules were submitted in draft form to the NRC on April 30, 2008. In a letter signed by James G. Luehman and dated June 30, 2008, the NRC had three comments on the draft rules. These comments have been incorporated into the final versions of the rules.

In addition, we have finalized the amendment to Ohio Administrative Code rule 3701:1-40-17. This rule was amended to incorporate comments received in a December 7, 2007 letter from your office signed by Robert J. Lewis. The rule was submitted in draft form to the NRC on April 30, 2008. In a letter signed by James G. Luehman and dated June 30, 2008, the NRC had no comments on the draft rule. This rule is equivalent to 10 CFR 30.35.
