Announcement - FPL CNO, Art Stall To Retire In 2010 And Mano Nazar Named New FPL CNO

After 12 years of outstanding service to Florida Power & Light (FPL), Art Stall, executive vice president of the nuclear division and chief nuclear officer, has announced his plan to retire following the first quarter of 2010.

Accordingly, effective Jan. 1, 2009, Mr. Stall is named president of FPL Group Nuclear, reporting to FPL Group Chairman and CEO Lew Hay, while Mano Nazar is named senior vice president and chief nuclear officer, reporting to Jim Robo, FPL Group President and Chief Operating Officer. This will provide a 15-month transition period, ensuring a secure and seamless transfer of responsibilities.

Mr. Stall joined FPL Company in 1996 as site vice president of the St. Lucie Nuclear Power Plant and was appointed to his current position in 2002. He has played a vital role in building the FPL Nuclear Division into the third-largest nuclear fleet in the country. As President of FPL Group Nuclear, Mr. Stall will focus his attention on outward-looking industry efforts in the areas of workforce planning, nuclear safety and the regulatory arenas. Mr. Stall currently chairs the Nuclear Energy Institute (NEI) Workforce Development task force, serves on the NEI Regulatory Process task force, and is a member of the Institute of Nuclear Power Operations (INPO) Training Accreditation Board. Mr. Stall will continue to promote clean, safe nuclear energy as an essential component of our country's long-term energy strategy.

Mr. Nazar joined FPL in 2007 as senior vice president and nuclear chief operating officer. He came to FPL from American Electric Power (AEP), where he had served as senior vice president and chief nuclear officer since 2003. Prior to that, Mr. Nazar held positions of increasing responsibility with Nuclear Management Company (NMC) and Duke Power Company. Mr. Nazar serves as chairman of the Industry Nuclear Power Council (NPC) Executive Committee.
