**Purpose of call: Obtain criticality calculation input and output files for NRC review of Amendment 3.**

**Discussion: NRC staff noted that the Amendment 3 submittal referenced a CD containing input and output files used in the criticality calculations, but that the CD was not submitted along with the amendment. SMUD committed to sending in the calculation input and output files to facilitate the staff's review. The NRC staff confirmed that there were no changes to the licensing drawings since the last SAR update. Additionally, the NRC staff indicated that the NRC would soon send an acknowledgment letter to SMUD, including the review schedule.**
