The purpose of this modification is to incrementally fund the contract in the amount of \$235,000.

Accordingly, the following change is made:

1. Section B.3. Consideration and Obligation – Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991), paragraph (c) is deleted in its entirety and replaced with the following:

(c) The amount currently obligated by the Government with respect to this contract is **\$408,155**, of which the sum of **\$376,179.72** represents the estimated reimbursable costs, and of which **\$31,975.28** represents the fixed fee.

Of the \$408,155 currently obligated, the funds are allotted to each task as follows:

Task A (Moore Ranch) - \$148,155
Task B (Nichols Ranch) - \$130,000
Task C (Lost Creek) - \$130,000
