SUBJECT: NOTIFICATION OF THE ISSUANCE OF THE DRAFT SUPPLEMENTAL
ENVIRONMENTAL IMPACT STATEMENT FOR THE NORTH ANNA POWER
STATION UNIT 3 COMBINED LICENSE APPLICATION REVIEW

The Honorable Chief Wallace:

The U.S. Nuclear Regulatory Commission (NRC) staff is reviewing an application submitted by the Virginia Electric Power Company, doing business as Dominion Virginia Power and the Old Dominion Electric Cooperative (collectively referred to as Dominion) for a combined license (COL) for construction and operation of one new nuclear power plant at its North Anna Power Station Unit 3 (NAPS) site near Mineral, Virginia. As part of its review of the proposed action, the NRC staff has prepared NUREG-1917; draft "Supplemental Environmental Impact Statement for the Combined License (COL) for North Anna Unit 3" (SEIS). The draft SEIS includes analyses of relevant environmental issues, including potential impacts to historic properties that reflect consultation and document the NRC staff's determination regarding the suitability of the proposed site for the construction and operation of one new nuclear plant.

As stated in our April 4, 2008, letter the NRC staff has determined that the area of potential effect (APE) for the COL action is the area at the power plant site and its immediate environs that may be impacted by land-disturbing activities associated with the construction and operation of the new unit. The NRC staff also notified you that in accordance with 36 CFR 800.8(c), the NRC staff is using the process required by NEPA for the preparation of the SEIS to comply with the obligations imposed under Section 106 of the National Historic Preservation Act of 1966, as amended (NHPA), in lieu of the procedures set forth in 36 CFR 800.3 through 800.6.

Through this letter, the NRC staff is forwarding the draft SEIS to the Eastern Shawnee Tribe of Oklahoma for your review and comment and will address your comments in the final SEIS, regarding the Dominion COL application. Pursuant to 36 CFR 800.8(c), we are requesting your comments on the draft SEIS and on our preliminary conclusions regarding historic properties. In accordance with our letter to you dated April 4, 2008, a copy of the draft SEIS is enclosed.

The NRC staff has conducted an environmental audit at the site and has reviewed historic and archaeological records. The NRC staff also contacted 15 other Native American Tribes identified as having potential interest in the proposed undertaking. To date, no comments have been received. In the context of the National Environmental Policy Act of 1969, under which the draft environmental impact statement was prepared, the NRC staff's preliminary determination is that the impacts of proposed plant on historical and archaeological resources is small and the draft SEIS describes the potential mitigation warranted. Under the provisions of the National Historic Preservation Act of 1966, the NRC staff's preliminary determination is that no historic properties will be affected by the proposed action.
