<b>Purpose of call: Discuss status of license transfer request and logistics for a pre-application meeting regarding the upcoming submittal of the Fort Saint Vrain (FSV) independent spent fuel storage installation (ISFSI) license renewal application</b>				
<b>Discussion:</b>				
1. DOE stated that the Idaho Operations Office site manager, Elizabeth Sellers, is leaving the DOE. DOE will verbally notify NRC of her temporary replacement, and will notify NRC in writing when a permanent replacement is named.				
2. DOE inquired about the status of the docketing of the ISF facility license transfer request; Ms. Helton stated that the federal register notice of docketing and the acknowledgement letter should be issued in the next couple of weeks.				
3. DOE asked whether the Foster Wheeler (FW) indirect license transfer request had any impact on the DOE license transfer request. Ms. Helton stated that the FW request did not include any changes to the license or its supporting documentation, and that the FW request will not impact the DOE request in terms of schedule.				
4. DOE requested a pre-application meeting to discuss the Fort Saint Vrain (FSV) independent spent fuel storage installation license renewal. DOE plans to submit FSV license renewal application in November later this year. DOE is following the guidance provided to Surry, Oconee. DOE is proposing not to do an aging management review (AMR) on two items: (1) individual fuel element grapple, since FSV is not licensed to move individual fuel elements; DOE is looking at container grapple; and (2) the transfer cask, which is no longer part of the license nor physically available -DOE is proposing to delete the transfer cask from the license in the renewal request as the facility is fully loaded and there is no current need to transfer fuel until sending fuel to the repository.				
5. DOE confirmed that the quality assurance (QA) plan included in the ISF license transfer request represents that the ISF facility is being included in revision 10 of the Yucca Mountain QA plan.
