SUMMARY AND CONCLUSIONS:

By letter dated June 13, 2008 (ML081930226), Umetco Minerals Corporation (Umetco) submitted the annual surety estimate for its Gas Hills uranium tailings site. The staff reviewed the document and requested additional information on October 27, 2008 (ML082940171). Umetco's response and revised surety cost estimate was submitted by letter dated January 9, 2009 (ML090140331). Additionally, on September 8, 2008 (ML081780626), NRC staff approved Umetco's Construction Completion Report, which demonstrated the completion of site reclamation. Based on this information and the approved Construction Completion Report, the staff has determined that the revised surety amount meets regulatory requirements and adequately provides for the completion of license termination activities at the site.

BACKGROUND:

The Umetco Gas Hills site is located in a remote area of central Wyoming, in Fremont and Natrona Counties, approximately 60 miles east of Riverton. The restricted area of the site consists of approximately 542 acres, of which Umetco owns 280 acres and the rest is under the jurisdiction of the U.S. Bureau of Land Management. The mill was constructed in 1959 and was shut down in 1984. Mill building decommissioning was completed in 1993. Site reclamation was completed in 2006, and approved by NRC on September 8, 2008.

For the 2008 surety update, Umetco reduced the estimated costs to reflect the completion and approval of reclamation and deleted previous cost estimates for work already performed and documented. The State of Wyoming still holds the bond (financial assurance instrument) for both the Wyoming and NRC reclamation amounts. The current NRC portion of the surety is \$9,662,086.

TECHNICAL EVALUATION:

The NRC staff evaluated the surety update information against the guidance in NUREG-1620, Rev. 1, Appendix C, and the regulations in 10 CFR Part 40, Appendix A, Criteria 9 and 10. Staff noted that the submittal met the license requirement for a surety update to be submitted 3 months prior to the September 13 anniversary date.

Enclosure 1

The individual costs included 10 percent for contractor's overhead and 10 percent for profit on unit costs. Also, 15 percent was added to the remaining costs for contingencies. The sub-total estimated cost was \$337,938. With addition of the Long-Term Surveillance fee, the proposed NRC surety is \$1,131,228.

The Gas Hills Pond No. 2, C-18 Pit, North and South Evaporation Ponds, and the Windblown Area, have all been reclaimed according to the site reclamation plans.

Groundwater Monitoring/Well Abandonment

Umetco requested and was authorized to use Alternate Concentration Limits for groundwater in March 2002. Excess wells have been reclaimed. Monitoring, as required by license condition was estimated to be \$42,700, based on current costs.

Fencing

In their January 9, 2009 letter, the licensee stated that they have completed construction of the fencing to restrict access to the site. However, to be conservative, the cost to complete the fencing is still included in the licensee's cost estimate for \$70,677.

Miscellaneous Costs

Site utilities, taxes, legal expenses, and a salary for a radiation safety officer were estimated by the licensee to be \$120,624. These miscellaneous expenses have gone down significantly since NRC approval of the reclamation activities at the site. Additional costs for final completion were estimated to be \$103,937 for site transfer activities.

Long-Term Surveillance Fee

The Long-Term Surveillance (LTS) fee was calculated correctly to be \$793,290. It is expected that no additional costs (e.g., groundwater monitoring or fence maintenance) will be identified in the LTS fee. This will be confirmed during review of the draft LTS Plan.

Conclusions:

The staff determined that the itemized activities in the submitted cost estimate reflect the anticipated efforts needed to complete license termination and to transfer the site to the U.S. Department of Energy for LTS. The proposed surety amount has been appropriately derived from reasonable itemized cost estimates.

Proposed License Condition Change:

Revise License Condition 55 to change the required surety amount to read "\$1,131,228."
