SUBJECT: RADIATION SAFETY OFFICER

This letter serves as a notification that Buckskin Mining Company holds an active U.S. Nuclear Regulatory Commission (NRC) License No. 49-27786-01 that authorizes the use of fixed gauging devices. As an NRC licensee you are required to submit a license amendment request when you change the Radiation Safety Officer (RSO) listed on this license. NRC became aware that the RSO listed on this license (Don E. Reynolds) retired in or around January 1, 2009. Please submit an amendment request proposing a new individual to become RSO. You will need to submit this individual's training certificate for NRC review and approval following the guidance provided in NUREG-1556, Volume 4. Possession of radioactive material contained in fixed gauging devices without a Radiation Safety Officer is a violation of NRC regulations.

NUREG-1556, Volume 4, describes the type of training and experience documentation that needs to be submitted to the NRC for an individual seeking to become a Radiation Safety Officer for a fixed gauge license. Such guidance can be found at:
