2) Physical Description

This shipment will consist of 4 x 30B "Heeled" Cylinders in sealed overpacks on 1 x 20' flatrack containing 27.04 kgs of Uranium. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, FISSILE (HEELS)

3) Transportation and Route Schedule
