Staff Holds Public Scoping Meeting to Discuss Environmental Issues Pertaining to the Combined License (COL) Application for Comanche Peak Nuclear Power Plant Units 3 and 4

On January 6, 2009, the staff conducted two public meetings, related to the COL application for Luminant Generation Company, LLC COL site in Glen Rose, Texas to solicit comments from the public on environmental issues related to the COLs. Over 150 people attended the meetings, including representatives of the NRC, Oakridge National Laboratories, Information Laboratories, Luminant, state and local governments, the nuclear industry, and members of the public. About 50 people provided comments. The public comment period for scoping ends on February 17, 2009. At the conclusion of the comment period, the staff will evaluate the comments, develop the scope of the draft environmental impact statement (EIS), and prepare the draft EIS, which is currently scheduled to be published December 2009.

Entergy Reconsidering Reactor Technology for River Bend and Grand Gulf Combined License (COL) Applications

By letter dated January 9, 2009, Entergy Operations, Inc. requested the NRC suspend, until further notice, the staff's review of the docketed COL applications for the River Bend Station Unit 3 and the Grand Gulf Nuclear Station Unit 3. Entergy plans to reconsider the General Electric-Hitachi ESBWR reactor technology, which was the basis for the COL applications. The staff plans to issue a response to Entergy's letter in the near future.

Public Quarterly Management Meeting on Yucca Mountain

On January 7, 2009, NRC and Department of Energy (DOE) management and staff held a public meeting (at NRC headquarters) on the proposed Yucca Mountain Project. This was the first Quarterly Management Meeting since receipt of the license application for a high level waste repository. With the production of NRC staff requests for additional information and the receipt of contentions, both the application review and the hearing process are underway. As a result, the meeting focused on the license application review process rather than specific technical concerns associated with the application. The new DOE organization for the Yucca Mountain Project, the schedule for future DOE submittals, and more efficient ways to respond to NRC requests for additional information were discussed. Representatives of the State of Nevada, interested stakeholders, the press, and other members of the public participated either at headquarters or via telecom or videoconferencing from (1) San Antonio, Texas, (2) Las Vegas, Nevada, or (3) other parts of the country.

On January 7, 2009, NRC staff held a public teleconference with DOE staff concerning requests for additional information about radionuclide transport.
