

Deadline for Filing Hearing Requests and Intervention Petitions

The deadline for filing a request for a hearing or a petition to intervene, where there is no *Federal Register* notice of an opportunity for hearing, is determined by the date of the related notice on the NRC's Web site. See 10 CFR 2.309(b)(4)(i). Where an opportunity for hearing is not published in the *Federal Register*, the information on this page constitutes the Web site notice referenced in 10 CFR 2.309(b)(4)(i), and all determinations of the timeliness of hearing requests and intervention petitions for purposes of Section 2.309(b)(4)(i) will be based upon the date of notice publication on this page. Where an opportunity for hearing is published in the *Federal Register*, the deadline for hearing opportunity is determined by the date of publication in the *Federal Register* and not the date of publication on this page.

The NRC will update this page to add notices as the NRC receives new applications or notices of intent for major licensing actions, and as opportunities arise for the public to request a hearing or file a petition to intervene in major licensing and enforcement proceedings. The NRC will also update this page to remove notices following the deadline for timely filing of a hearing request or intervention petition.
