Dear Mr. Gresham:

By letter dated November 24, 2008, Westinghouse submitted for U.S. Nuclear Regulatory Commission (NRC) staff review Topical Report (TR) WCAP-12610-P-A & CENPD-404-P-A, Addendum 2/WCAP-14342-A & CENPD-40-NP-A, Addendum 2, "Westinghouse Clad Corrosion Model for ZIRLO™ and Optimized ZIRLO™." The NRC staff has performed an acceptance review of TR WCAP-12610-P-A & CENPD-404-P-A, Addendum 2/WCAP-14342-A & CENPD-40-NP-A, Addendum 2. We have found that the material presented is sufficient to begin our comprehensive review. The NRC staff expects to issue its request for additional information by June 5, 2009, and issue its draft safety evaluation by November 23, 2009. The NRC staff estimates that the review will require approximately 300 staff hours including project management time. The review schedule milestones and estimated review costs were discussed and agreed upon in a telephone conference between Mr. Thomas Rodack, Director of Quality and Licensing Program, and the NRC staff on January 22, 2009.

Section 170.21 of Title 10 of the *Code of Federal Regulations* requires that TRs are subject to fees based on the full cost of the review. You did not request a fee waiver; therefore, NRC staff hours will be billed accordingly.
