The purpose of this modification is to increase the obligated amount of the subject task order by \$4,326,000.00 from \$107,977,281.26 to \$112,303,281.26.

Accordingly, the following change is hereby made:

Subsection B.8 - <u>CONSIDERATION</u> AND <u>OBLIGATION</u>, is deleted in its entirety and substituted with the following in lieu thereof:

- "a. The total estimated amount (ceiling) of this task order for the products/services ordered delivered, and accepted under this task order is <u>\$121,405,016.31</u>. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the task order period provided such orders are within any maximum ordering limitation prescribes under this contracts.
- b. The amount presently obligated with respect to this task order is <u>\$112,303,281.26</u>. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this task order. The obligated amount shall, at no time, exceed the task order ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order.
