Dear Sir or Madam:

Pursuant to 10 CFR 72.212, "Conditions of general license issued under § 72.210," the Nebraska Public Power District (NPPD) is notifying the Nuclear Regulatory Commission (NRC) of its intent to load spent nuclear fuel in approved storage casks in the Cooper Nuclear Station Independent Spent Fuel Storage Installation. 10 CFR 72.212(b)(1)(i) requires notification to the NRC at least 90 days prior to the first storage of spent fuel under the general license. NPPD plans to begin its initial spent fuel loading campaign on or after April 13, 2009. The following additional information is provided as required by 10 CFR 72.212(b)(1)(i):
