The purpose of this modification is to: 1) Incorporate additional workshop titled, "Source Evaluation Panel Procedures Workshop" to be held on December 4, 2008; 2) Increase the Total Estimated Price for Option Year 2 by \$3,115 which changes the total from \$284,251 to \$287,366; and 3) Change the Project Officer from Ms. Randi Neff to Mr. Carlos Montgomery.
