SUBJECT
 Control No. 317585: Re request to add a Seaman Model C-200 portable gauge having a Ra-226 sealed source in a portable gauge for possession under License No. 24-32157-01.

SUMMARY
 In our telephone conversation, we discussed the current requirement to place possession limits for each radionuclide authorized on a license when the license is amended. Mr. Stanley requested the following possession limits be placed on the license: Cesium-137, 16 millicuries; Americium-241, 500 millicuries; and Radium-226, 4.5 millicuries.

Mr. Finn also related that Mike Stanley the currently named RSO, for the subject license, is no longer an employee of the Company and that he, Brandon Finn, is to be the named RSO replacement on subject license. He further stated that he has completed a portable gauge training program and is an experienced gauge user with about 15 years experience.

I requested that he provide the following additional information:

1. Provide a copy of a document signed by both the RSO designate and a high level management representative, confirming the appointment of Mr. Finn as the replacement RSO. Please include not only the signature but also the printed name and title of position held.
2. Also, please include a statement in which the RSO designate confirms his awareness of the duties and responsibilities of the RSO position.
3. Provide information on the training and experience of the RSO designate to demonstrate his qualifications to serve as the RSO. This should include a copy of any training certificate(s) and length of experience as a portable gauge user.
