Dear Sir or Madam,

We wish to amend NRC License No. 24-18733-01 in the following ways:

1. Add the following naturally occurring and accelerator-produced radioactive material (NARM) to our license.

Authorized Use	Requested NARM	Form	Maximum Amount
10 CFR 35.100	I-123	Any	As needed
10 CFR 35.200	Tl-201, In-111, Ga-67, I-123	Any	As needed
10 CFR 35.65	Co-57	Sealed Sources	Not exceeding 1.11 GBq (30mCi) per source

We have reviewed our Radiation Protection Program and radioactive materials license application and we have no program changes to report to the NRC as a result of adding the requested NARM to our license. We do not use PET isotopes under this license.

2. Add Charles Armstrong, M.D., as an Authorized User for 35.100, 35.200, and 31.11. Dr. Armstrong is an experienced Authorized User and has been listed as an AU on NRC License 24-18733-01 (Amendment 27). A copy of this license is enclosed.
3. Remove Kianoush Rezaei, M.D., and Garry J. Brown, D.O., as Authorized Users from our license.
4. Place the Authorized Use 10 CFR 35.400 on our license to an "in storage" on "on hold" status. Dr. Brown is no longer with Ozarks Medical Center and was the only Authorized User for 10 CFR 35.400. We request a hold status for 10 CFR 35.400 while we search for a new Radiation Oncologist. We have never performed an exam nor received or used any radioactive materials under 10 CFR 35.400 at Ozarks Medical Center.
