Dear Mr. Wadley,

The U.S. Nuclear Regulatory Commission, (NRC) conducted a scoping process, from July 22, 2008, through September 22, 2008, to determine the scope of the NRC staff's environmental review of the application for renewal of the operating license for Prairie Island Nuclear Generating Plant, Units 1 and 2. As part of the scoping process, the NRC staff held two public environmental scoping meetings in Red Wing, Minnesota, on July 30, 2008, to solicit public input regarding the scope of the review. The scoping process is the first step in the development of a plant-specific supplement to NUREG-1473, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants (GEIS)," for Prairie Island Nuclear Generating Plant, Units 1 and 2.

The NRC staff has prepared the enclosed environmental scoping summary report identifying comments received at the July 30, 2008, license renewal environmental scoping meetings, by letter, and by electronic mail. In accordance with 10 CFR 51.29(b), all participants of the scoping process will be provided by a copy of the scoping summary report. The transcripts of the scoping meetings are publicly available at the NRC Public Document Room (PDR), located at One White Flint North, 11555 Rockville Pike, Rockville, Maryland 20852, or from NRC's Agencywide Documents Access and Management System (ADAMS).
