Regulatory Commission (NRC) Revision 6 of the MOX Project Quality Assurance Plan
(MPQAP) for the design and construction of the Mixed Oxide Fuel Fabrication Facility (MFFF).
This revision supersedes that of Reference (A).

Enclosure (1) provides the revised MPQAP. This revision incorporates the NRC's Reference (B)
approval of an exemption to the 10 CFR 21.3 definition of Commercial Grade Item. The
definition is included in paragraph 7.2.12.A. of the MPQAP, to fulfill the Item 1 commitment of
Reference (B). MPQAP paragraphs 7.2.12.B. and C. fulfill the Item 2 commitment of Reference
(B).

In addition, Enclosure (1) deletes the description of Management Measures formerly in the
Introduction (these are more fully described in the License Application) and revises the
organization described in Section 1. Changes are summarized following the Table of Contents.
