Enclosed is Amendment No. 01 to your NRC Material License No. 13-32700-01 in accordance with your request. Please review the enclosed document carefully and be sure that you understand all conditions.

If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that I did not list technetium-99m as a separate line item on your license because the regulations in 10 CFR 35.65(e) already permit you to obtain this material in quantities "as needed."

I noted that the letterhead used for your letter dated October 14, 2008, showed your corporate name as "Oncology Hematology Associates of Southwest Indiana." In your previous correspondence with us, the last three words of this name were not requested or incorporated into your license. If this is your correct corporate name, please request an amendment to your license to change it.

Your request to send you "some NRC posts regarding the radiation worker's rights" should have been addressed by the contents of the "New license packet" sent along with your original license, especially Form NRC 3 and 10 CFR Part 19. These documents are also available on our website at <http://www.nrc.gov>. I directed the enclosure of the "New license packet" with this amendment also.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
