Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note, we have not authorized Dr. Jeffrey Flermoen for oral administration of sodium iodide I-131 because the additional information that was submitted for Dr. Michael M. Graham (preceptor) was incomplete. We are missing the timeframes Dr. Graham held the authorization for the materials authorized in 10 CFR 35.300. If you wish to pursue this matter, please provide the information requested by Ms. Casey in the letter dated December 2, 2008 (enclosed).

NRC's Regulatory Issue Summary (RIS) 2005 31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. 
