FROM DATABASES HOLDING SENSITIVE INFORMATION

The purpose of this memorandum is to withdraw the Computer Security Policy for Logging and Erasure of all Computer-Readable Data Extracts from Databases Holding Sensitive Information that was issued on September 16, 2008 (ML081850718). Communication with other federal agencies has revealed that most agencies are struggling with finding a way to implement the database extract logging requirement and the Office of Management and Budget is now reexamining the requirement and will be providing new guidance. Once the new guidance is received, we will issue an appropriate policy.

The requirement to log extracts of personally identifiable information, specified in Yellow Announcement 069, Protection of Personally Identifiable Information, September 19, 2006, remains in effect.
