The purpose of this modification is to:

1) exercise Option Year One (September 26, 2008 through September 25, 2009) in accordance with FAR Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the period of performance through September 25, 2009.

2) increase the amount of the order (ceiling) by \$15,532,411.37, from \$15,176,738.26 to \$30,709,149.63. The ceiling amount of \$30,709,149.63 consists of estimated labor costs of \$29,761,780.09 and estimated other direct costs not-to-exceed \$947,369.54.

A letter providing preliminary written notification of the Government's intent to exercise Option Year One was emailed to OAO Corporation on August 1, 2008.

Accordingly, Section C.29, Duration of Contract, is deleted and replaced with the following:

The ordering period for this contract shall commence on September 26, 2007 and will expire September 25, 2009. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216.18 - Ordering). The term of this contract may be extended at the option of the Government for one additional one-year period.

In addition, Section C.21, 52.217-9, Option to Extend the Term of the Contract, paragraph c, is corrected to read as follows:

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed three years.

This modification does not obligate any funding.

All other terms and conditions of the subject order remain unchanged.
