Enclosed is Amendment No. 08 to your NRC Material License No. 24-26530-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Your letter dated October 21, 2008, requested the addition of accelerator produced materials to your license. Please note that this change was "automatically" made for you when 10 CFR 30.4, "Definitions," was amended on October 1, 2007, to expand the scope of materials covered by the term "byproduct materials." Similar changes were made to 10 CFR 35.100, 35.200, etc. on the same date with the same expansion of the scope of covered materials by revision of "Definitions."

However, it is incumbent upon you to evaluate your licensed program within the expanded scope of these new authorizations and to request appropriate amendments if or when addresses of use, areas of use, or other program elements change or are expected to change. In this amendment, I "tied-down" your letter dated October 21, 2008, by inclusion in Condition No. 15., in order to capture the areas of use where you use accelerator -produced materials.



This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
