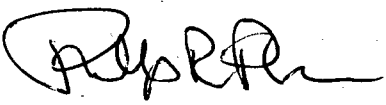

The specific source allocated for this shipment is a QSA Global manufacture Special Form sealed source in a model CDC.CY4, X2074 capsule, Serial Number 41125B.

This specific source is covered by "Registry of Radioactive Sealed Sources & Devices Safety Evaluation of Sealed Sources" number MA-1059-S-191-S.

This specific source is covered by "IAEA Certificate of Competent Authority, Special Form Radioactive Materials Certificate # USA/0612/S-96, Revision 3. (this capsule was formerly covered under "IAEA Certificate of Competent Authority GB/311/S-85).
