The purpose of this modification is to increase the obligated amount by \$76,000 from \$217,500 to \$293,500. Accordingly the contract is modified as follows: paragraphs (b) and (c) of Section B.3 of the contract entitled: "Consideration and Obligation Cost Plus Fixed Fee (JUN 1988) is revised to read as follows:
"(b) The amount currently obligated by the government with respect to this contract is \$293,500."
"(c) It is estimated that the amount currently allotted will cover performance through May 23, 2009."
All other terms and conditions remain the same.
