The purpose of this modification is to: 1) Exercise Option Year Three of the contract, thereby extending the period of performance from April 19, 2009 through April 18, 2010, 2) increase the ceiling amount of the contract by \$955,442.00 from \$2,622,907.68 to \$3,578,349.68. Accordingly, the contract is hereby modified:

1.) Section A. Subsection A.1, CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988), the first sentences of paragraph (a) is deleted and replaced with the following:

“(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$3,578,349.68.

2.) Section A. Subsection A.1, DURATION OF CONTRACT PERIOD (MAR 1987), is deleted in its entirety and replaced with the following:

“The ordering period for this contract shall commence on April 19, 2006 and shall expire on April 18, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 – Ordering) The term of this contract may be extended at the option of the Government for an additional one year.”
