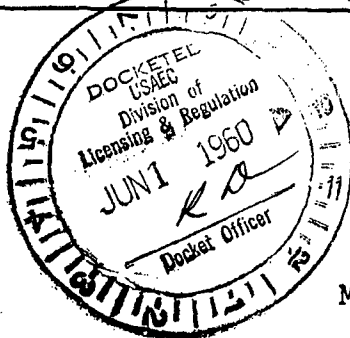

Gentlemen:

In your letter of May 11, 1960 you requested information pertaining to our new company, Engelhard Industries, Inc., a Delaware corporation. You stated that this information is needed in order to consider the transferring of License No. SNM-98 to this new company. We, therefore, write to supply the information you have asked for.

The name of the new company is Engelhard Industries, Inc., a Delaware corporation and its principal office is 113 Astor Street, Newark 2, New Jersey. Enclosed herewith is copy of form marked, "Security Clearance Register" dated May 10, 1960 in which we gave Headquarters, First U. S. Army a list of names, addresses, and the places of birth of all officers and directors of Engelhard Industries, Inc., a Delaware Corporation. All of them are citizens of the United States except (b)(6) who has filed a Declaration of Intention to become a United States citizen and who has been cleared for SECRET by Headquarters, First U. S. Army. Mr. Keith Courtney Acutt, a director, is not an employee of the company.

There are two (2) foreign stockholders - Ingesi Investments, Ltd., 70 Jameson Avenue, Central, Salisbury C4, Southern Rhodesia and Anglo-Canadian Mining & Refining Company, Ltd., 55 Yonge Street, Toronto, Ontario, Canada, and together they own 13.9% of the voting stock. This pertains to stockholders of Engelhard Hanovia, Inc. Engelhard Hanovia, Inc. owns all of the stock of Engelhard Industries, Inc.
