Enclosed is Amendment No. 28 to your NRC Material License No. 21-14894-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887, or me at either (630) 829-9841 or (800) 522-3025, so that we can provide appropriate corrections and answers.

In correspondence dated October 17, 2008, and January 27, 2009, you indicated that you wished to release your former locations of use located at 38855 Hills Tech Drive, Farmington Hills, Michigan and 1635 44<sup>th</sup> St. S.E., Suite C-180, Grand Rapids, Michigan for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former locations of use noted above and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area and it is suitable for unrestricted use.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
