- You have reviewed your current license and you indicated that there are no current licensed activities in Virginia. You would like to remove the Virginia address from your license. You are currently evaluating what was used there (most likely sealed sources or check sources for classroom demonstration) in the past to ensure proper decommissioning. You would like to retain your NRC license. You are NOT requesting a Virginia license.
- You have reviewed your current license and no longer find it necessary for authorization to conduct licensed activities in NRC-regulated states, and therefore request that your existing NRC license be amended to authorize the use of material only in the Commonwealth of Virginia. You request that this be effective on the date the Agreement between the NRC and the Commonwealth of Virginia is signed. You understand that upon the effective date of the Agreement between the NRC and the Commonwealth of Virginia, you will be licensed by the Commonwealth of Virginia to conduct work at temporary job sites in the Commonwealth and as such, must file a NRC Form 241 (reciprocity) prior to performing any work in NRC jurisdictions (non-Agreement States) or in areas of Exclusive Federal Jurisdiction within an Agreement State.
