JOINT INTERVENORS' RE-REVISED INITIAL POSITION STATEMENT, PRE-FILED DIRECT TESTIMONY, EXHIBITS AND EXHIBIT LIST

Pursuant to the Atomic Safety and Licensing Board's (the "Board") February 4, 2009 Memorandum and Order (the "Administrative Order"), ¹ Joint Intervenors² hereby re-file a Re-Revised Initial Position Statement (omitting a reference to JTI000036 in footnote 70), a Re-Revised Pre-Filed Direct Testimony of Dr. Shawn Young in Support of EC 1.2 (inserting a reference to JTI000020 in Answer 20), and a Re-Revised Exhibit List (deleting JTI000036, omitting references to witnesses other than Mr. Powers in connection with JTI000032, and renaming the former JTIR00041 as JTIR20041). Joint Intervenors have also marked JTIR20041 with the exhibit number on the first page of the document, and hereby re-file the exhibit in accordance with the Administrative Order.

As noted in the Administrative Order in section (C)(1)(a), Joint Intervenors' exhibits JTI000020 and JTI000036 were not referenced in specific discussions by particular witnesses or panels. As for the former, Joint Intervenors inadvertently omitted a reference to JTI00020 in the string cite of references in Answer 20 to Dr. Young's Pre-Filed Direct Testimony in Support of EC 1.2. To rectify such inadvertent omission, Joint Intervenors have revised Answer 20 to include the reference to JTI000020, and hereby refile a re-revised version of the Pre-Filed Direct Testimony. As for the latter, Joint Intervenors' do not intend to offer JTI000036 into evidence. Therefore, Joint Intervenors have re-revised their Initial Position Statement to omit reference to JTI00036 in footnote 70, and hereby re-file a re-revised version of the Initial Position Statement.

In addition, as referenced in footnote 3 of the Administrative Order, Joint Intervenors' exhibit JTI000032 is only referenced in the testimony of Mr. Powers, but is listed in the exhibit list as being referenced by three witnesses. Joint Intervenors have revised their exhibit list to reflect that only the testimony of Mr. Powers references JTI000032.

Finally, pursuant to the Administrative Order, Joint Intervenors hereby re-file exhibit JTIR00041, which is now marked as JTIR20041, with the exhibit number marked on the first page of the document. The exhibit list has been revised to reflect this change.
