This confirms authorization provided on February 12, 2009, in which the contractor waived the requirement for a 30-day written notice of intent to exercise option year two.

The purpose of this contract modification is to: (1) exercise option year two in accordance with FAR Clause 52.217-9, Option to Extend the Term of the contract, extending the period of performance through February 11, 2010; (2) increase the contract ceiling amount by \$102,000.00 from \$204,000.00 to \$306,000.00; (3) provide incremental funding in the amount of \$30,000.00, thereby increasing the obligated amount from \$140,000.00 to \$170,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B.1 CONSIDERATION AND OBLIGATION- COST REIMBURSEMENT (JUN 1988) ALTERNATE I (JUN 1988), paragraphs (a) and (b) are deleted in their entirety and replaced with the following:

- "(a) The total estimated cost to the Government for full performance under this contract is \$306,000.00
- (b) The amount presently obligated by the Government with respect to this contract is \$170,000.00."

Under Section C.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988), the first sentence of the paragraph is deleted in its entirety and replaced with the following:

"The ordering period for this contract shall commence on February 12, 2007 and will expire on February 11, 2010."

All other terms and conditions of the contract remain unchanged.

A summary of obligations, from award date through the date of this action, is given below:

Total FY07 Obligations \$50,000.00 Total FY08 Obligations \$90,000.00 Total FY09 Obligations \$30,000.00

Total NRC Obligations \$170,000.00

This modification obligates FY09 funds in the amount of \$30,000.00.
