On January 14, 2009, the U. S. Nuclear Regulatory Commission (NRC) completed a temporary inspection at your Callaway Plant. The inspection covered the transition from a contract to a proprietary security force. The enclosed inspection report documents the inspection results, which were discussed on January 14, 2009, with Mr. L. Graessle and other members of your staff.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings of significance were identified.
