SUBJECT: SUMMARY OF JANUARY 22, 2009, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On January 22, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees submitted and briefly summarized new FAQ 07-0030. Licensees and the NRC staff discussed the remaining open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Industry representatives stated that they would publish their positions on FAQs related to NUREG/CR-6850 outside the FAQ process via reports issued by the Electrical Power Research Institute.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on February 19, 2009, via teleconferencing.
