The purpose of this modification is to increase the obligated amount by \$40,000.00 from \$225,000.00 to \$265,000.00. Accordingly, paragraph (c) of section B.3 entitled: "Consideration and Obligation - Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991)" is revised to read as follows:
"(c) The amount currently obligated by the government with respect to this contract is \$265,000, of which the sum of \$245,753.91 represents the estimated reimbursable costs and of which \$19,246.09 represents the fixed fee."

All other terms and conditions remain the same.


