SUBJECT: LICENSE AMENDMENT

By letter dated May 30, 2008, you informed the U.S. Nuclear Regulatory Commission (NRC) that you wished to remove the facility located at 5523 Kendall Street, Boise, Idaho from your NRC radioactive materials license. The close-out survey for the facility was submitted as supporting documentation to your request letter. Based on our review of your submittal and the historical file for the facility, a request for additional information (RAI) was generated and provided to you on January 12, 2009. In addition, as part of our review it was determined that an environmental assessment was not required since all materials used at the facility were categorically excluded under 10 CFR 51.22(c)(20)(i). You submitted a response to the RAI on February 16, 2009.

The NRC staff has reviewed the supporting documentation to your request and your response dated February 16, 2009 to our RAI. Based on the documentation submitted and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from the facility and the facility located at 5523 Kendall Street, Boise, Idaho is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." Based on these conclusions, no further remediation or actions with respect to NRC regulated material at this facility is required.

Please find enclosed Amendment No. 09 to License No. 11-27705-01MD, authorizing the removal of your facility from the license. In addition, based on our telephone call, the mailing address for your license has been changed to your location of use in Garden City, Idaho. Please review the enclosed document carefully and be sure that you understand all conditions. If there are any questions, please contact me at (817) 276-6552.

Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

NRC expects licensees to conduct their programs with meticulous attention to detail and a high standard of compliance. Because of the serious consequences to employees and the public that can result from failure to comply with NRC requirements, you must conduct your radiation safety program according to the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, note that you must:

1. Operate by NRC regulations 10 CFR Part 19, "Notices, Instructions and Reports to Workers: Inspection and Investigations," 10 CFR Part 20, "Standards for Protection Against Radiation," and other applicable regulations.
2. Notify NRC in writing of any change in mailing address.
3. By 10 CFR 30.36(d) and/or license condition, notify NRC, promptly, in writing, and request termination of the license:
  - a. When you decide to terminate all activities involving materials authorized under the license whether at the entire site or any separate building or outdoor area;
  - b. If you decide not to acquire or possess and use authorized material; or
  - c. When no principal activities under the license have been conducted for a period of 24 months.
4. Request and obtain a license amendment before you:
  - a. Change Radiation Safety Officers;
  - b. Order byproduct material in excess of the amount, radionuclide or form authorized on the license;
  - c. Add or change the areas or address(es) of use identified in the license application or on the license, except for areas of use where byproduct material is used only in accordance with either 10 CFR 35.100 or 35.200; or
  - d. Change the name or ownership of your organization.
5. Submit a complete renewal application or termination request at least 30 days before the expiration date on your license. You will receive a reminder notice approximately 90 days before the expiration date. Possession of radioactive material after your license expires is a violation of NRC regulations.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
