1. Under Section C- CONTRACT CLAUSES, is revised to incorporate clause C17 – 52.217-8 Option to Extend Services and is inserted in full text as follows:

C-17 52.217-8 Option to Extend Services (Nov 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer my exercise the option by written notice to the Contractor within 10 days before the contract expires.

(End of clause)

2. The period of performance is extended (for an additional 6 months) from 20 February 2009 through 19 August 2009 at no additional cost to the government.
