The purpose of this unilateral modification is as follows:

1. To revise Section 17. SCHEDULE – SUPPLIES OR SERVICES (b) to correctly reflect the total contract duration period that was revised in Modification No. 2 that added 2 months to the 5 month option period, for a total of 7 months. Modification No. 2 did not revise Section 17. SCHEDULE – SUPPLIES OR SERVICES (b) to reflect the correct modified length of the option period.

2. To revise the total contract duration period set forth in Federal Acquisition Regulation (FAR) 52.217-9 – OPTION TO EXTEND THE TERM OF THE CONTRACT to correctly reflect the total potential period of performance length that is calculated by adding the 7 month base period, 7 month option period, and the 6 month option to extend the services period, for a total of 20 months as opposed to 18 months.

Accordingly, the delivery order is hereby modified as follows:

 The last sentence in Section 17. SCHEDULE – SUPPLIES OR SERVICES (b) is revised as follows:

FROM:

"Optional Period August 1, 2008 through December 31, 2008."

(2) Paragraph (c) of FAR Clause 52.217-9 is revised as follows:

FROM:

"(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 18 months."

<u>TO</u>:

"(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 20 months."

All other terms and conditions remain unchanged.
