In response to your earlier request on the status of RAIs on NA3 FSAR Rev. 1, please note:

- a. At this time, I foresee no new RAIs, besides the ones already issued to date. See RAI No. 2026, 2027, 2120, 2121, 2130, 2131, and 2221.
- b. The other concern which may result in another RAI is whether Dominion will provide an explanation in the Reviewer's Aid for the undocumented difference in distances from the ISFSI to nearest resident, 870 m vs. 1303 m (FSAR Rev. 1, Section 12.2.2.4.4, p.12-8). I have not seen the Reviewer's Aid. We may have to issue an RAI if the Reviewer's Aid is not forthcoming soon or the explanation is deemed to be incomplete.
