

# AP1000 TECHNICAL REPORT REVIEW

## **Response to Request For Additional Information (RAI)**

RAI Response Number: RAI-SRP 9.1.2-SEB1-08 Revision: 0

#### Question:

Section 5 "DCD Markup" in TR 54 Rev. 2 shows the deletion of Figure 9.1-2 (sheets 1 and 2) and Figure 9.1-3 (sheet 2 of 2), with no apparent replacement figures. The staff requests Westinghouse to explain why these figures were deleted, and also to identify the new figures, if any, that replace the deleted figures.

### Westinghouse Response:

The figures in question were inadvertently included as being deleted in the "DCD Markup" section of the supplemental Reader's Aide that was provided to facilitate the review process. A comparison with the actual version of TR-54, Rev. 2, will show that these figures in question were not changed in Revision 2 of TR-54. This was an editorial error when creating the Reader's Aide only and does not impact the TR or the DCD.

Note: Figures 9.1-2 (sheets 1 and 2) and 9.1-3 (sheet 2) were replaced in TR-54, Rev. 1, a few months before TR-54, Rev. 2, was issued. These versions of the figures were correctly included in Rev. 17 of the DCD.
