COL Information Item 12.05-1, Operational Radiation Protection Program, references several Regulatory Guides (RGs) which are outdated according to the consolidated guidance of NUREG 1736. In addition, the reference to Part 72 in this item is incorrect. Please revise COL item 12.05-1 so that the Part 72 reference is changed to Part 71, RGs 8.20, 8.26, and 8.32 are deleted from the listing of RGs, and RG 1.206 is added.
