Request for Extension for Re-submittal of Information System Security Plans for the American Centrifuge Lead Cascade in Piketon, Ohio, SP-2605-0015 and SP-2605-0018

In a letter dated January 10, 2006 (Reference 1), the DOE approved the Master Plan SP-2605-0015 for *Stand-alone Special Category Systems, Process Controls and Workstations Supporting Process Controls Processing Classified Information at Protection Level = 1* and requested that the plan be re-submitted for approval within three years of the date of the letter.

In a second letter dated January 10, 2006 (Reference 2), the DOE approved the Information System Security Plan: SP-2605-0018 *Network System Processing Classified Information at PL=1* and requested that the plan be re-submitted for approval within three years of the date of the letter.

USEC requests a 90 day extension for submission of plans SP-2605-0015 and SP-2605-0018 to maintain accreditation of the systems and avoid interruption of these essential information systems. This extension is requested to complete the review and approval of the plans in accordance with the requirements of DOE M 205.1-5.
