Dear Mr. Weber:

Pursuant to Reference 1, on July 28, 2008 USEC Inc. (USEC) submitted a request for U.S. Nuclear Regulatory Commission (NRC) review of non-substantive changes to Information Systems Security Plans (ISSPs) for establishing classified computer networks associated with USEC's American Centrifuge Program (Reference 2). On August 27, 2008 the U.S. Department of Energy (DOE) transmitted comments to the NRC on the ISSP (Reference 3). The purpose of this letter is to provide USEC response to DOE comments.

Based on DOE comments, Enclosure 1 contains the page changes to SP 2605-0025, Master Information Systems Security Plan for Networked Systems Processing Classified Information at PL=1; and SP 2605-0026, Information System Security Plan for the Classified Data Processing Network System Processing Classified information at PL=1.


