SUBJECT: Change “Executive Director” to “President” in Corporate Bylaws

WHEREAS: The Timbisha Shoshone Tribal Council passed its Non-Profit Corporations Code on November 25, 2008 for the purpose of creating non-profit corporations under the jurisdiction of the Tribe; and

WHEREAS: The Timbisha Shoshone Yucca Mountain Oversight Program Non-Profit Corporation (“Corporation”) was formed on November 25, 2008 under the auspices and parameters of the Timbisha Shoshone Constitution and the Non-Profit Corporation Code; and

WHEREAS: The Tribal Council created, pursuant to the Tribal Constitution and the Tribal Non-Profit Corporations Code, the Timbisha Shoshone Yucca Mountain Oversight Program Non-Profit Corporation to advance the oversight of the Yucca Mountain Repository Project on behalf of the Tribe, to ensure the Tribe participates fully in the Yucca Mountain oversight activities, to ensure future generations have the means to continue the Yucca Mountain oversight activities, and to receive funds from the federal government pursuant to the Nuclear Waste Act and other laws or grants to advance the aforementioned purposes; and

WHEREAS: The first and current members of the Board of Directors of the Corporation are as follows: Mr. Joe Kennedy, Ms. Madeline Esteves, and Ms. Pauline Esteves; and

WHEREAS: The Board of Directors adopted the Corporate Bylaws for the Corporation on November 25, 2008; and

WHEREAS: The Board of Directors considers it in the best interest of the Corporation, for the purposes of clarity and consistency, to make certain changes to the Corporate Bylaws.

NOW, THEREFORE, BE IT RESOLVED, The Board of Directors of the Corporation, so as to be consistent with the Timbisha Shoshone Non-Profit Corporations Code, direct that “Executive Director” be replaced with “President” throughout its Corporate Bylaws.

BE IT FURTHER RESOLVED, President shall lead meetings of the Corporation and act as the primary spokesperson for the Corporation.


