SUBJECT: REGIONAL LICENSE INVOLVED IN THE TRANSFER OF
REGULATORY AUTHORITY TO THE COMMONWEALTH OF
VIRGINIA

In your November 6, 2008, memorandum you requested that Region III review the enclosure to your memo to determine if we had additional licensees that have a location of use in Virginia. In addition, you requested that we perform the necessary licensing actions and inspections for those licensees on the enclosure that are located in our region.

In addition, Ken Lambert of my staff talked to Jim Kottan of your staff regarding the responsible region for conducting inspections of those licenses with locations of use in Virginia. Based on the discussion, we provided Mr. Kottan the enclosed list of Region III licensees with locations of use in Virginia that required an inspection by March 31, 2009. It was also our understanding that Region I staff will be conducting the inspections in Virginia.

Finally, in a memorandum, dated December 23, 2008, we had requested Region I staff to inspect three Cardinal Health Nuclear Pharmacy locations in the State of Virginia. It is our understanding that Region I staff still plans to conduct these inspections.
