In accordance with the USEC Inc. (USEC) American Centrifuge Lead Cascade (LC) Facility Security Program (NR-2605-0002, Docket Number 70-7003) and the American Centrifuge Plant (ACP) Security Program (NR-3605-0004, Docket Number 70-7004), USEC hereby submits a request for U.S. Nuclear Regulatory Commission (NRC) review of the Security Program for the American Centrifuge Program at the Curtiss-Wright facility in Cheswick, PA. This request is submitted to initiate security regulatory oversight by the NRC.

This submittal satisfies the requirement discussed within USEC's NRC-approved LC Facility Security Program, Chapter 2, Section 25 and the ACP Security Program, Chapter 2, Section 2.21, which requires a "Security Facility Approval for Classified Work" to be requested through the NRC's Nuclear Security and Incident Response organization and the requirements contained in 10 *Code of Federal Regulations (CFR)* Part 95.
