**JOINT INTERVENORS' REVISED REBUTTAL STATEMENT, PREFILED

Additionally, while the purpose of such re-filing is to amend the documents pursuant to the In Limine Order, Joint Intervenors have also corrected two typographical errors in Mr. Sulkin's Pre-filed Rebuttal Testimony for EC 1.2. The first correction is in question three which misstated the current cubic feet of flow (cfs) as 3,262 instead of the correct 3,567. The second correction is in question four where the term "Thurmond Dam" was replaced with "Waynesboro gage." All other questions and answers remain unchanged to the extent that no change was required by the In Limine Order.
