Dear Congressman Smith:

I am responding to your letter of February 3, 2009, in which you requested that the Commission postpone an affirmation session that was tentatively scheduled for February 4, 2009, in connection with adjudicatory matters pending before the Commission with respect to the license renewal application for the Oyster Creek Nuclear Generating Station (Oyster Creek). In particular, you requested that the Commission postpone the tentative affirmation session and defer any decision on the license renewal application until recommendations of the Atomic Safety and Licensing Board relating to the Oyster Creek drywell liner have been implemented.

The Commission postponed the affirmation session that was tentatively scheduled for February 4, and the Oyster Creek license renewal matter remains under consideration by the Commission. As noted in my January 5, 2009, letter to you, under Commission regulations, the Commission has an adjudicatory role in the Oyster Creek license renewal proceeding. An appeal is currently pending before the Commission with respect to the license renewal application, specifically related to the 3-D structural analysis of the drywell liner mentioned in your letter. Due to the nature of the Commission's role, all members of the Commission must remain impartial while the case is pending. At this time, therefore, the Commission cannot discuss or comment on issues involved in this matter. The Commission may, however, always discuss the status of the proceeding and the performance of the facility generally.

A copy of your letter and this response will be served on the participants in the Oyster Creek proceeding.

Dear Chairman Klein:

The US NRC web page indicates that The Nuclear Regulatory Commission has tentatively scheduled an Affirmation Session on License Renewal for Oyster Creek Nuclear Generating Station for tomorrow allermoon. I respectfully request that this meeting be postponed and any decision on extending the operating license be deforred until the recommendations of the Alomic Safety and Licensing Board (ASLB) relating to drywell corrosion have been implemented.

On January 22, 2009, Excion submitted to the Commission only a "summary report" of the results of their 3-D structural analysis of the Oyster Creek drywall shell. As I stated in my December 4, 2008 letter to you and your fellow NRC Commissioners. the ASLB has called for a more rigorous review of the completed 3-D analysis and for the NRC staff to perform or have performed a comprehensive and in-depth review of the complete analysis package. Not only has the NRC staff not yet received the full analysis package, but a letter I received just five days ago from R.W. Borchardt, Executive Director for Operations for the NRC, points out that the staff has not yet completed a review of even the "summary report." The NRC should not make a final decision on license renewal while the recommendations put forth by the ASLB have not been fully integrated or achieved.

The NRC staff must demonstrate vigilance and thoroughness in order for the NRC to earn and maintain public confidence in its ability to comprehensively oversee nuclear power plant safety issues. Rushing to an Affirmation Session while critical information is outstanding, still under review, or yet to be released to the public only serves to undermine public confidence in the NRC's ability and commitment to fully ensure public safety.
