The purpose of this modification is to incrementally fund the contract in the amount of \$20,000.

Accordingly, the following section of the contract is hereby modified:

1. Paragraph 1 - CONSIDERATION AND OBLIGATION, is hereby deleted in its entirety and replaced with the following:

- (1) The total estimated amount of this order (ceiling) is \$794,811.
- (2) The amount presently obligated with respect to this order is \$680,000. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
